## Brecknock Museum & Art Gallery

### Statement of Principles for funds raised for Conservation & Display Project

1. The Brecknock Society and Museum Friends (BS&MF) as an independent charity has the principal object of assisting the development of the Brecknock Museum & Art Gallery, including through the purchasing of equipment and artefacts.
2. The BS&MF is a local funding Partner in the renovation of the Brecknock Museum & Art Gallery as part of the Cultural Hub Brecon (CHB) project, which is led by Powys County Council (PCC). We have been working with PCC in this capacity since the first application to the Heritage Lottery Fund was made in 2008.
3. This partnership will continue once construction and 'fit-out' work on the Cultural Hub Brecon has been completed, under the framework of a suitable governance structure.
4. BS&MF has set a target of £54.6K for funds to be raised under the Conservation & Display Project (henceforth 'The Project'). The Project is additional to the CHB project, and no funds raised for The Project shall be used for the CHB project.
5. Funds raised for The Project will only be used for the funding of refurbishment activities and scheduled items listed in Appendix 1 and illustrated or described in the Prospectus for the Fundraising Appeal for the Conservation & Display Project.
6. Individual donations will be able to be made either directly to the BS&MF via its Treasurer / Bank Account or on-line via a BS&MF Campaign on the JustGiving website. All funds raised will be held ring-fenced by the BS&MF until there is an appropriately documented payment via PCC in relation to an invoice for the relevant items and refurbishment activities.
7. This funding appeal will be of finite duration and will be closed on 31 December 2017 or when the full sum is raised – whichever is the sooner. (If donors wish to make a contribution to the BS&MF's work in assisting the development of the Brecknock Museum & Art Gallery after the closing of this funding appeal, this can be discussed separately with the BS&MF.)
8. No items or activities carried out via BS&MF under The Project are work that Powys CC has a duty to carry out.
9. Donations will be pooled into a project fund to pay for any of the refurbishment activities and scheduled items, unless the donor states that their donation is for a specific item in Appendix 1. Should any specific item become fully funded by the latter, the BS&MF reserves the right to use the donation for other scheduled items.
10. Any money remaining in The Project funds after all the refurbishment activities and scheduled items have been carried out will be held over by the BS&MF for a further similar future item or activity in Brecknock Museum & Art Gallery.
11. All donors will be acknowledged publicly in notices in the renovated Museum & Art Gallery unless the donor states that he or she wishes to remain anonymous.

### **A. Specialist conservation activities (refurbishment) on the following:**

1. Gorsedd stone
2. Pillar box
3. Drinking trough
4. Powder testing mortar
5. Portrait of John Jeffreys Pratt
6. Stump stitchwork picture
7. Straw work box
8. Statue of Boadicea
9. Welsh harp

### **B. Items to be made and purchased:**

1. Further display cabinets for museum
2. Specially-designed cabinet for storage and display of watercolour paintings

All the items include for installation in or adjacent to the Brecknock Museum & Art Gallery
